Parties are a central feature of the American political system, but remain poorly understood. In this class we will survey their role in contemporary politics in both political institutions and the electorate. We will learn about parties' evolution over the course of U.S. history. We will explore topics such as shifts in party coalitions, parties' evolving structures, parties' role in policymaking, regulation of parties and trends in attitudes about parties.

Students will be evaluated via midterm and final exams, quizzes, a Senate race case study and class participation.

There will be eight quiz days. Quizzes –which will be brief- will *not* be announced, but will be focused on the readings assigned for that day's class. Students who miss a quiz without a medical excuse receive a zero for that quiz. However, students may drop their lowest two quiz grades, including zeroes from missed quizzes, without any excuse required.
