Parties are a central feature of the American political system, but remain poorly understood. In this class we will explore their role in contemporary politics, with attention given to both political institutions and the electorate. We will learn about parties' evolution over the course of U.S. history. We will explore topics such as shifts in party coalitions, parties' evolving structures, parties' role in policymaking, regulation of parties and trends in attitudes about parties.

**Course Requirements:** This is a demanding course. The most important requirement (and the best preparation for success) is coming to class having done the readings and ready to participate. Students will be evaluated via midterm and final exams, quizzes, a Senate race case study and class participation.

There will be ten quiz days. Quizzes –which will be brief- will *not* be announced, but will be focused on the readings assigned for that day's class. There are no make-ups and students must be physically present at the time the quiz is given in class to receive a non-zero grade. Students who miss a quiz without a medical excuse receive a zero for that quiz. However, students may drop their lowest two quiz grades, including missed quizzes. The quiz average for students who miss a quiz due to an excused absence will be calculated based on a revised denominator, e.g. their seven highest grades out of nine, instead of their eight highest out of ten.
