# GVPT317/GVPT388M: MOCK TRIAL

# SPRING 2018

The Mock Trial course is designed to introduce students to the key principles of trial advocacy through experiential learning and to prepare them for intercollegiate competitions sponsored by the American Mock Trial Association (AMTA). The emphasis of the course will be on learning through student participation in exercises and trials as well as the observation and analyses of other students' performances. Through engaging in competition with classmates and teams from other institutions, students develop critical thinking and public speaking skills as well as knowledge of legal practices and procedures. As members of Maryland Mock Trial, you will travel to tournaments as representatives of the University of Maryland to compete against other colleges and universities.

#### Learning Objectives

This course is designed introduce students to the trial process and advocacy techniques through experiential learning and participation in AMTA sponsored intercollegiate mock trial competitions. Through the readings and exercises for the course, students are expected to:

- Develop an understanding of the trial process and AMTA rules.
- Develop a basic knowledge of the methods and theories used in trial advocacy.
- Develop effective oral communication skills to clearly and coherently present opening statements, direct examinations, cross examinations, and closing arguments.
- Develop proficiency in the analysis and presentation of evidentiary arguments.

Students who are not selected to compete at ORCs or Nationals will be given the opportunity to compete in in-house practice trials and asked to complete group assignments. Completion of these assignments will be incorporated into the class preparation and improvement during the semester grading sections.

#### **Attendance Policy**

Students are expected to take full responsibility for their own academic progress in this course. Students are expected to attend all classes and team trials. If your trial begins at 6:30, you are expected to be in your seat prepared for the trial prior to 6:30. This usually means you want to be in the room by 6:15 on Wednesdays and by 8:30 on Sundays. If you have a conflict, please let us know (we are very accommodating as long as we have advanced notice).

If for any reason, you will be late for class or cannot attend, you must contact the program director, your individual coach, your team captain or, in an emergency only, another member of the class. Because your teammates will be relying on your attendance, we ask you treat mock trial similar to employment. Just as you need to call in sick for work, you must call in sick to class (and inform us as early as possible your brother is getting married out of town). #### **Travel Policy**

Maryland Mock Trial competes in tournaments throughout the country. Often students will be requested to drive fellow teammates to the competitions where accommodations will be provided. When travelling, student drivers are not allowed to drive after 11:30 PM, in inclement weather, or in any other circumstance in which the coaching staff concludes driving would not be safe. The senior coach at all tournaments shall decide whether the drive home meets these conditions. A coach's decision that driving is not safe is final (a written excuse will be provided for any university-related function). The program will pay for hotel rooms for all students who express reasonable safety concerns after the coaching staff determines that driving is safe (for example, if the driver of a car is exhausted after a tournament).

#### **Emergency Policy**

Students are strongly encouraged to provide an emergency contact as well as to disclose any serious health conditions or allergies that may result in a medical emergency. We will ensure that your information remains confidential, unless an emergency occurs that requires disclosure for your safety.

#### **Class Schedule**

All students are expected to be prepared for team meetings and practice trials on both Wednesday evenings and Sundays during the day. Student will be notified of the trial schedule prior to class meetings.

#### **Student Resources**

The University provides appropriate accommodations for students with disabilities.
